PROPOSAL TO ACQUIRE SINGAPORE PRESS HOLDINGS LIMITED AND POTENTIAL CHAIN OFFER FOR SPH REIT

1. Introduction

Morgan Stanley Asia (Singapore) Pte. ("MS Singapore") refers to the announcement (the "Possible Offer Announcement") dated 29 October 2021 made by Cuscaden Peak Pte. Ltd. ("Cuscaden"), a company formed by a consortium comprising Tiga Stars Pte. Ltd. (a subsidiary of Hotel Properties Limited), Adenium Pte. Ltd. (a wholly-owned subsidiary of CLA Real Estate Holdings Pte Ltd) and Mapletree Fortress Pte. Ltd. (an indirect, wholly-owned subsidiary of Mapletree Investments Pte Ltd), to acquire all the issued and paid-up ordinary shares in the capital of Singapore Press Holdings Limited (the "Company") excluding treasury shares (the "Proposed Acquisition").

As stated in the Possible Offer Announcement, if Cuscaden proceeds with the Proposed Acquisition and subject to the finalisation of the terms of, among others, the Proposed Acquisition, the completion of the Proposed Acquisition will result in Cuscaden incurring an obligation to undertake a chain offer ("Potential Chain Offer") for all the units in SPH REIT in accordance with the Singapore Code on Take-overs and Mergers (the "Code").

MS Singapore is the financial adviser to Cuscaden in respect of the Proposed Acquisition and the Potential Chain Offer and is required under to the Code make these disclosures.

2. Dealings

Pursuant to Rule 12.1 of the Code and the Practice Statement on the Exemption of Connected Fund Managers and Principal Traders under the Code, MS Singapore wishes to report dealings by associates of MS Singapore in the securities of the Company and SPH REIT ("**Relevant Securities**") for their own account or for the account of discretionary investment clients, details of which are set out in the table below.
